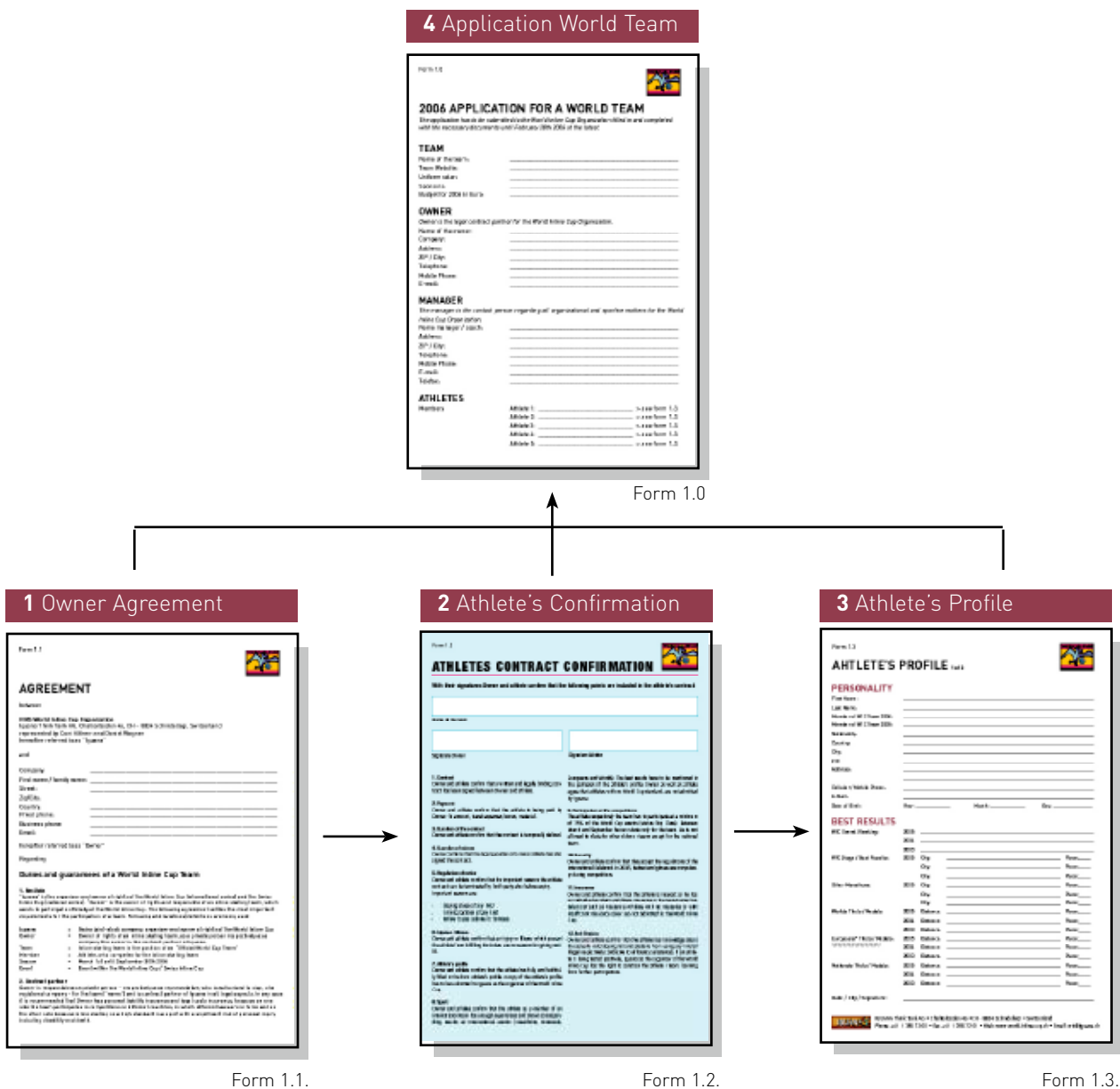

# WORLD TEAMS 2009 – THAT’S HOW THE REGISTRATION FUNCTIONS

Due to our experiences in the last years the registration of a World Team 2009 has to be done more detailed and more specifically – on one side to protect the athletes and on the other side to create clear legal responsibilities. That is why the following documents have to be submitted: 1. Agreement between the owner of a team and the WIC organizer, 2. Binding contract between the owner of a team and an athlete, 3. Detailed information about an athlete including proof of insurance. Those documents have to be submitted with the registration paper. The registration has to be done until February 27th at the latest.

## **Duties and guarantees of a World Inline Cup Team**

### **1. Recitals**

“Iguana” is the organizer and owner of rights of the World Inline Cup (international series) and the Swiss Inline Cup (national series). “Owner” is the owner of rights and responsible of an inline skating team, which wants to participate officially at the World Inline Cup. The following agreement settles the most important requirements for the participation of a team. Following abbreviations/definitions are being used:

Iguana	=	Swiss joint-stock company, organizer and owner of rights of the World Inline Cup
Owner	=	Owner of rights of an inline skating team, as a private person respectively as a company the owner is the contract partner of Iguana.
Team	=	Inline skating team in the position of an “Official World Cup Team”
Member	=	Athlete, who competes for the inline skating team
Season	=	March 1st until September 30th 2009
Event	=	Event within the World Inline Cup / Swiss Inline Cup

### **2. Contract partner**

Owner is responsible as a private person – respectively as a representative, who is authorized to sign, of a registered company – for the team (“name”) and is contract partner of Iguana in all legal aspects. In any case it is recommended that Owner has personal liability insurance and legal costs insurance, because on one side the team participates in competitions in different countries, in which different laws are in force and on the other side because inline skating on a high standard is a sport with a significant risk of personal injury including disability and death.



### 3. Guarantees and proofs

- 3.1. Owner guarantees, that written and legally binding contracts will be completed between him and each member.
- 3.2. Owner guarantees, that each member has personal liability insurance and individual accident and illness insurance. Members with no insurance cover are not admitted to the event.
- 3.3. Owner guarantees, that the member skates only for the team and under the name of the team during the whole season except for the national championships and international championships like European or world championships. The member is not allowed to skate for different teams or clubs.
- 3.4. Owner guarantees, that he has the financial matters to let participate the team respectively the members to a minimum of 75% (seventy-five per cent) of the official World Inline Cup events (Top Class events). The actual World Inline Cup calendar is retrievable on the website [www.world-inline-cup.com](http://www.world-inline-cup.com) (see point. 6 ff). The events can take place in Europe, Asia and the United States.
- 3.5. Owner hands over the following documents until February 15th.:
  - a) Registration application as "Official World Inline Team". Iguana can reject an application, if the team or the single members don't comply with the requirements, defined in the Rulebook valid for the upcoming season.
  - b) Declaration signed by Owner as well as the member, saying that the athlete's contract contains the most important points as defined in form 1.2. Especially that each member has an individual accident and illness insurance. If necessary, Iguana hands over the proof of insurance to the rescue team respectively to the local organizers. Athletes with NO insurance or who did NOT communicate their insurance are not admitted to the events.

### 4. Liability

- 4.1. Owner is liable for behaviour and actions of the team and the single members in connection with the events, especially for:
  - a) damages, resulting from the team or from single members, for example damages of the infrastructure in the official hotels.
  - b) injuries to third persons, resulting from the team or from single members.
  - c) financial obligations which the team or the single members did not fulfil, for example consummation with costs in the official hotels.
  - d) costs for medical care, in case the owner registers – contrary to this agreement – an athlete who has no insurance or an insufficient insurance.
- 4.2. If on the occasion of an event something occurs that can bring Iguana or the local organizers into disrepute or if Owner does not or only insufficiently take the liabilities and responsibilities defined in point 3 and 4, Iguana has the immediate right to exclude the team or single members from the competition, further legal steps reserved.
- 4.3. If Iguana is in a lawsuit / legal proceedings with Owner, with one or with more members, Iguana has the immediate right to exclude the team or single members from the competition until the lawsuit is settled by mutual agreement or by order of an independent court.

### 5. Risk

- 5.1. Owner and members are aware that Inline Skating is a sport with high speed which takes place on official ground (street) and with a significant risk of personal injury including disability and death. They confirm that they take part on their own risk at the event and that they use equipment of a type and condition reasonably necessary to safely participate in this activity.



## 6. Events / competitions

- 6.1. At the World Inline Cup (WIC) different events take place within March and September, as Top Class or Class 1 events
- 6.2. The actual calendar is retrievable under [www.world-inline-cup.com](http://www.world-inline-cup.com)
- 6.3. In case of an annulment of the event or part of it directly attributed to circumstances commonly defined as "major force" or to drastic measures through authorities, Owner can not demand back the registration fee nor the travel expenditures.

## 7. Sponsoring

- 7.1. In case Iguana can arrange a sponsor for the team, Iguana receives an annual commission of 15 % (fifteen per cent) of the annual cash amount (net). The payment of the commission is due after the receipt of the first sponsoring instalment.

# ATHLETES CONTRACT CONFIRMATION

With their signatures owner and athlete confirm that the following points are included in the athlete's contract

## 1. Contract

Owner and athlete confirm that a written and legally binding contract has been signed between Owner and athlete.

## 2. Payment

Owner and athlete confirm that the athlete is being paid by Owner: fix amount, travel expenses, bonus, material.

## 3. Duration of the contract

Owner and athlete confirm that the contract is temporally defined.

## 4. Guardian of minors

Owner confirms that the legal guardian of a minor athlete has also signed the contract.

## 5. Regulation of notice

Owner and athlete confirm that for important reasons the athlete contract can be terminated by both party also before expiry.

Important reasons are:

- Doping abuse of any kind
- Criminal actions of any kind
- Failure to pay salaries or bonuses

## 6. Injuries / illness

Owner and athlete confirm that an injury or illness, which prevent the athlete from fulfilling his duties, are no reasons for giving notice.

## 7. Athlete's profile

Owner and athlete confirm that the athlete has fully and faithfully filled in the form athlete's profile. A copy of the athlete's profile has to be submitted to Iguana as the organizer of the World Inline Cup.

## 8. Sport

Owner and athlete confirm that the athlete as a member of an international team has enough experiences and shows corresponding results at international events (marathons, Nationals, Europeans and Worlds). The best results have to be mentioned in the palmares of the athlete's profile. Owner as well as athlete agree that athletes, with no World Cup standard, are not admitted by Iguana.

## 9. Participation at the competitions

The athlete respectively the team has to participate at a minimum of 75% of the World Cup events (status: Top Class). Between March and September he can skate only for the team. He is not allowed to skate for other clubs or teams except for the national team.

## 10. Security

Owner and athlete confirm that they accept the regulations of the International Rulebook. In 2007, helmet and gloves are compulsory during competitions.

## 11. Insurance

Owner and athlete confirm that the athlete is insured: or he has an individual accident and illness insurance or the team/owner has taken out such an insurance. Athletes with no insurance or with insufficient insurance cover are not admitted to the World Inline Cup.

## 12. Anti Doping

Owner and athlete confirm that the athlete has knowledge about the actually valid doping list and abstains from using any kind of illegal respectively conducive to efficiency substances. If an athlete is being tested positively, Iguana as the organizer of the World Inline Cup has the right to sanction the athlete / team: banning from further participations.

Further, he/she hereby grants full permission to use any photographs, motion pictures, recordings, or any other record of this event for any legitimate purpose, including commercial advertising.
